

IGA CAMPAIGN IN SUPPORT OF LA TABLÉE DES CHEFS

« Scratch for La Tablee »

Participation Rules

The "Scratch for La Tablee" campaign, organized by La Tablee des Chefs, will take place from Thursday, March 26, 2026, at 8:00 a.m. (ET) to April 15, 2026, at 11:59 p.m. (ET) in all IGA and Corbeil Électroménagers stores in Quebec. This campaign is authorized by the Régie des alcools, des courses et des jeux (RACJ) under license number **L-03078**.

Draws:

- Three (3) weekly draws of 50 prizes each, with a total value of \$15,600, will be held on April 9, 16, and 23, 2026, at 11:00 a.m. (ET), for a total of 150 winners.
- Two (2) grand prizes will be drawn on April 23, 2026, at 11:00 a.m. (ET) (2 winners).

All draws will take place at the headquarters of La Tablee des Chefs, located on rue Adoncour, Longueuil, QC J4G 2M6.

1. ELIGIBILITY

The campaign is open to Quebec residents aged 18 and over. Void if uncovered or altered. A mobile phone is required. Internet access and a valid email address are required for registration and participation in the Contest (the "Entry"). A total of 50,000 scratch tickets will be distributed at participating locations from March 26 to April 15, 2026, or while supplies last.

EXCLUSIONS:

Employees, representatives, and/or agents of the Organizer of the Contest (La Tablee des Chefs), its parent companies, subsidiaries or affiliates, IGA stores, IGA ambassadors and influencers, Prize Suppliers and their advertising or promotional agencies, as well as any other entity involved in the design, production, implementation, administration, or execution of the Contest (collectively, the "**Parties Concerned**"), and, respectively, any person with whom such an excluded Participant resides or any member of their immediate family (each, an "**Excluded Participant**"). For the purposes of the Contest Rules (**the "Rules"**), the term "immediate family" includes the father, mother, brother, sister, child, husband, wife, or common-law partner of an Excluded Participant.

For clarity, an eligible Participant who is not an Excluded Participant is referred to as a "**Participant.**"

Each participant must participate exclusively in their own name and for their personal benefit only.

2. PARTICIPATION

- Each ticket is valid for a single entry ;
- The ticket price is non-refundable, and the ticket cannot be exchanged for cash ;
- By participating, you acknowledge that you have read and accepted the Campaign Rules, and agree to comply with the Participation conditions outlined in these Rules.

CAMPAIGN PARTICIPATION

Each four dollar (\$4) donation made exclusively at the cash register of participating stores in connection with the "Scratch for La Tablee" campaign entitles the donor to receive one (1) scratch ticket containing a unique code. Each unique code provides one (1) entry into the applicable weekly draws and one (1) entry into the grand prize draws, in accordance with these Official Rules.

PARTICIPATION IN WEEKLY AND GRAND PRIZE DRAW

The participant must check the box to confirm their acceptance of these Rules and the terms of participation. To be eligible for a chance to win a complete set of high-end Blomberg appliances with a total value of over \$25,000, or \$10,000 in IGA gift cards, the participant must also enter their unique code on grattezpourlatablee.com and complete the registration process by creating a profile associated with this unique code. As part of the registration, the participant will be required to provide their first name, last name, email address, phone number, date of birth, and full mailing address. The unique code must be entered **no later than April 15, 2026, at 11:59 p.m. (ET)**.

Each ticket purchased provides one (1) Participation for a chance to win one (1) prize in the weekly draw corresponding to the purchase period, as well as one (1) Participation for a chance to win one of the two (2) grand prizes in the grand prize draw.

Participants may obtain up to three (3) additional Participations for each correct answer in the bonus game (three questions about the organization). These additional Participations apply to both the weekly draw corresponding to the ticket's purchase period and the grand prize draw. Participations related to weekly draws are valid only for the applicable draw, whereas Participations related to the grand prize draw are cumulative and remain valid throughout the entire campaign, regardless of the weekly draws.

Fifty (50) weekly prizes will be drawn on April 9, 16, and 23, 2026, at 11:00 a.m. (ET). The draw for the two (2) grand prizes will take place on April 23, 2026, at 11:00 a.m. (ET), at the headquarters of La Tablee des Chefs.

Eligible purchase periods for weekly draws:

- April 9, 2026 draw: tickets purchased between March 26 and April 2, 2026
- April 16, 2026 draw: tickets purchased between April 2 and April 9, 2026
- April 23, 2026 draw: tickets purchased between April 9 and April 15, 2026

Each ticket is valid only for the weekly draw associated with its purchase period. Following each weekly draw, all Participations related to weekly prizes are reset to zero. Tickets are not transferable to subsequent weekly draws, and a new ticket must be purchased to participate in future draws.

Winners will be selected at random and contacted by a representative of La Tablee des Chefs.

GRAND PRIZES

There are two (2) grand prizes to be won as part of the "Scratch for La Tablee" campaign among participants who have submitted their unique code online. The first prize consists of a complete set of high-end Blomberg appliances, with a total value of over \$25,000. The second prize is \$10,000 in IGA grocery gift cards.

- Blomberg 30" stainless-steel built-in single electric wall oven model BWOS30200SS. True European Convection, self-cleaning mode, Sabbath mode, full-touch LED display and 3.9 cu ft capacity. Valued at three thousand two hundred ninety-nine dollars and ninety-nine cents (CAD \$3,299.99) + taxes ;
- Blomberg AVIVA 24" built-in dual-zone wine and beverage cooler with French doors, Model BSC42DB3. Capacity of 21 bottles and over 60 cans, two independently controlled temperature zones, UV-tinted Low-E glass, and adjustable shelves. Valued at one thousand seven hundred forty dollars (CAD \$1,740) + taxes ;
- Blomberg 30" built-in over-the-range microwave in stainless steel, Model BOTR30100SS. 1.5 cu.ft. capacity, 1,000 W cooking power, 2-speed 300 CFM vent, preset cooking modes, and cooktop lighting for easy and efficient cooking. Valued at nine hundred ninety-nine dollars (CAD \$999.00) + taxes ;

REMARKS ON THE PRIZES

Prizes are **not transferable or redeemable for cash**. Under no circumstances shall La Tablée des Chefs be responsible for late submissions, including delays caused by technical difficulties related to the website.

La Tablée des Chefs reserves the right to **substitute weekly prizes with other items of equal or lesser value**, depending on availability. La Tablée des Chefs is not responsible for printing errors or technical issues. Any attempt at fraud will result in disqualification.

The Corbeil Gift Card must be TREATED LIKE CASH, and it's valid at any Corbeil Appliances store in Quebec/Ontario. 4. AWARDING OF WEEKLY PRIZES AND GRAND PRIZE DRAW

Selected participants (the **"Selected Participant(s)"**) must complete the Release Form (the **"Release Form"**) in order to claim their prize.

WEEKLY PRIZES

The Selected Participants in the weekly prize draws will be contacted by phone on the Monday following each draw, at the number listed in their profile on grattezpourtatablee.com. An SMS will be sent first, which includes a link to the Release Form. The Release Form is also accessible directly on the Selected Participants' profile on grattezpourtatablee.com. If no response is received within forty-eight (48) hours, La Tablée des Chefs will follow up with a phone call.

The Release Form must be completed within ninety (90) days following the end of the campaign. Failure to comply will result in the participant forfeiting their prize.

DELIVERY OF WEEKLY PRIZES

Once the Release Form has been duly completed on the Selected Participant's profile, La Tablée des Chefs will send the weekly prizes by mail to the Selected Participants. The prizes will be sent within a period of two (2) to six (6) weeks following the automatic receipt of the completed Release Form.

GRAND PRIZES

La Tablée des Chefs, or its designated representative, will make up to **three (3) attempts** to contact the Selected Participants by phone and/or email, using the contact information provided in their profile on grattezpourlatablee.com. DELIVERY OF GRAND PRIZES

Corbeil Électroménagers

Once the Release Form has been duly completed and returned to La Tablée des Chefs, the Selected Participant will be contacted by Corbeil Électroménagers. The complete set of high-end Blomberg appliances, with a total value of over \$25,000, will be delivered by Corbeil Électroménagers on a mutually agreed-upon date.
